Are all windows and screens intact; is there any indication of an attempted forced entry? Are all of the outdoor water/hose connections secure and turned off?

Is the pool water at the proper level, or is it too high or too low? What is the Visual condition/color of the pool water? Are there any newspapers, flyers, advertisements lying around on the property, driveway, yard, or lawn areas? Are any vehicles parked in front of the home on the road, or parked in the driveway? We can obtain the make of the vehicle, the color, and plate number, and state of registration information.

All of your questions can be answered in a timely manner, once we receive your written request for your site visit, along with your very specific instructions on exactly what you need to know.
